The 3rd FL-EUR Conference will be organised in Amsterdam by the FL-EUR and the Amsterdam Centre for Family & Law of the Vrije Universiteit Amsterdam on Friday 2 May 2025.

Family Law in Europe: Academic Network (<u>FL-EUR</u>) is an academic initiative, uniting prominent family-law experts from 31 European jurisdictions. In 2022-2023 the FL-EUR experts and reporters have completed detailed National Reports on the legal regulation of empowerment and protection for vulnerable adults in their jurisdictions. These reports have been published on the <u>FL-EUR website</u>.

This conference will explore the latest developments in statutory measures, ex lege measures, and voluntary measures, offering a comparative overview based on the FL-EUR national reports. It will also highlight insights and best practices by examining both the law in the books and its application in practice in pioneering countries.

The aim of the Conference is to share the results of the FL-EUR comparative research project, to provide an overview of insights and best practices that other countries might benefit from and to bring together scholars, policy makers and practitioners working in the field of legal support and protection of adults.
